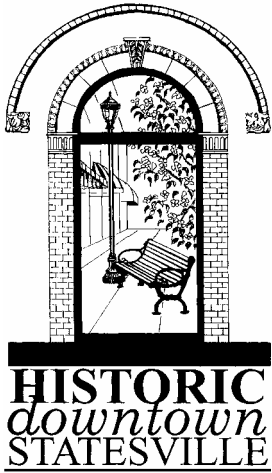
1. Each displaying artist requires separate registration, **even those artists currently owning/renting gallery or studio space in the City of Statesville.**
2. Complete Registration Form and include Full Payment (\$20.00 Application Fee per event) PAYABLE TO: Downtown Statesville Development Corporation.
3. Submit Three (3) IMAGES of your work. Submissions may be by e-mail (info@downtownstatesvillenc.org) or submitted in a self-addressed stamped envelope to fit your juried material (if return is requested).
4. You will be contacted regarding your acceptance or denial. If you are NOT chosen by jury, the registration fee check will be returned.
5. If selected by jury - You will be notified 2 weeks prior to the Crawl of your display location. Artists will be partnered with a downtown business by the Art Crawl Committee. Artists are responsible for all items required to display artwork.
6. Display spaces may vary by location and space availability. Set up time should be worked out between the downtown business owner and artist. The Art Crawl officially begins at 5:00 pm and ends at 9:00 pm.
7. A listing on the brochure advertising the event will highlight you as a guest artist.
8. You are totally responsible for all sales and sales taxes.
9. Press releases are provided to the local media.

Dear Artists,

Downtown Statesville is currently in the planning stages for the second *Downtown Statesville Art Crawl*. This event will be held on Friday, March 14, 2008 from 5 – 9 pm. We are looking for artists to partner with downtown businesses to display their art work during the Crawl. The whole community will be invited! Iredell Museums will host a kick-off party at their Court Street Gallery and downtown businesses will be encouraged to stay open late and offer music and refreshments. A map will be created to help guide people around the Art Crawl.

Artists who would like to participate in the Art Crawl are required to submit an application along with the \$20 application fee for consideration. Please read the application carefully as we are on a tight timeline in planning the March 14 Art Crawl.

The “product” that we are presenting to Statesville and the surrounding community is an Art Crawl. This means that the offerings must be of an “artistic nature” and may NOT include “items purchased for resale” or other items of a “non-artistic nature”. If you have questions or concerns about the qualification of your products, please contact us at 704-878-3436.

All applications are due by February 19, 2008. If selected by the jury, you will be notified two weeks prior to the Crawl of your display location. Artists will be partnered with a downtown business by the Art Crawl Committee. Display spaces may vary by location and space availability.

Once your work is juried and accepted, there will be NO REFUNDS unless the event is cancelled by the Downtown Statesville Development Corporation. (Weather will NOT be cause for cancellation of the event.) In no way will the Downtown Statesville Development Corporation, Iredell Museums or Iredell Arts Council be held responsible for any lack of sales, lack of viewers, the weather, or its effects on the scheduled event.

The committee will make every effort to advertise the *Downtown Statesville Art Crawl* as a whole to the community and to direct the attendees to the visiting artist’s locations. Thank you for your interest in participating in this event.
